The **PURPOSE OF THIS CERTIFICATE** is to notify **“You the Purchaser”**, Palmdale Oil Company Inc. has been requested by the State to collect and remit Sales Tax on the sales and use of dyed fuel products, unless the **“PURCHASER”** is exempt under the guidelines mandated by the Department of Revenue.

The undersigned (‘Buyer’) hereby certified the following under penalties of perjury:

**“YOU THE PURCHASER”** may be tax exempt and by your signature are requesting that you **DO NOT** want Palmdale Oil Company to collect and remit **SALES TAX** to the Department of Revenue on your behalf that if any Sales Tax are due, you the purchaser will pay directly to the State. **Buyer is responsible** for all Sales and Use tax unless the purchaser has been certified **TAX EXEMPT** by the Department of Revenue.

If your purchases are for **RESALE** you must provide a copy of your **ANNUAL RESALE CERTIFICATE** to Palmdale Oil Company, Inc. which includes your tax exempt number.

Buyer will provide a new certificate to the seller annually or if any information in this certificate changes.  
If Buyer uses the diesel fuel to which this certificates relates for a purpose other than an exempt use, the buyer is responsible to remit the tax

Buyer understands that the fraudulent use of this certificate may subject Buyer and all parties making such fraudulent use of this certificate to a fine or imprisonment, or both, together with the cost of prosecution.  
THE BUYER WILL BE LIABLE FOR ANY AND ALL STATE SALES TAX and penalties including the DOR mandatory penalty of 200% of the tax.”

This is **NOT** a legal document confirming any **TAX EXEMPTION**, You the purchaser must contact the Department of Revenue to acquire an official exemption.

**Palmdale Oil Company Inc., is responsible by law to provide the department of Revenue with a list of customers who purchase dyed fuel and who have not had the sales tax collected and remitted by the supplier.**
